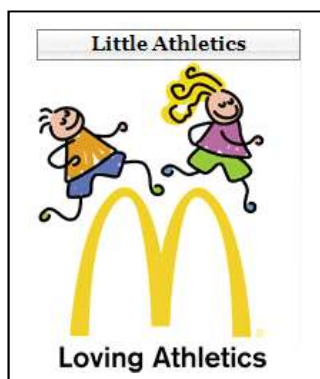


Registration Fees
